Junior Development:

Brian Guyer reporting for Jennifer Lowe.

- Goody bags were provided to Junior skiers at States
- A Junior Development clinic will be held at Sunset Lakes in March
- Donna Switzer suggested targeting Juniors from the West Palm area for a clinic.

Old Business:

Recognition of most improved Juniors at States was missed. Kerry and Brian will determine a basis for determining "most improved" and notify recipients via Email or mail prior to Regionals.

New Business:

There was discussion regarding how teams are funded to attend competitions, and how contributions can be made to the teams. USOC funds are no longer available. Fund raisers previously generated dollars but are no longer held. Some teams are funded through USA Water Ski; the Southern Region also distributes funds to Southern Region skiers; and contributions are made to teams from individual contributors.

If the Florida Federation donates through USA Water Ski, we can donate to a restricted fund and designate that contribution to a particular team. We can also contribute to Southern Region skiers through the Southern Region.

Based on the understanding that teams going to the CAN-AM Challenge are not currently funded, and that the participating Florida skier is Jon Travers, a motion was made that the Board consider a Florida Federation donation of \$500 each to Jon, Lelani (Team Manager), and Jack (Coach). The motion was passed that the Board consider that recommendation in a timely manner.

The board and the council members have the action to figure out how the Florida Federation can most effectively donate to teams; how we can designate to Florida skiers or Southern Region skiers.

Lelani suggested team fund raisers at State and Regional competitions.
