MINUTES OF FLORIDA FEDERATION BOARD MEETING December 3, 2016

Old Business: The need for bringing in a new Treasurer was discussed and members are encouraged to seek an interested person. Discussion then followed about marketing the Florida Federation. Monica Seal has offered and will coordinate a Facebook page. Monica would also like to have a tent at the State tournament to promote the Federation and she will assist with this. (The Federation banner needs to be located.) The next item is to remind the membership and tournament hosts of the dues increase in 2017 to \$10 individual and \$20 family. This will be posted on the Federation website and tournament hosts will be reminded during the tournament selection today. Discussion then followed regarding the meeting at the State tournament in July. Brian Guyer made a motion to hold the annual meeting on Friday night with the time posted and a maximum of one hour. The motion was unanimously seconded and approved.

New Business: As of right now there is no bid for the State Tournament. Jody Seal indicated that the Pickos' site may consider submitting a bid. At the request of AWSA President Jeff Surdej, Jody Seal requested that the State qualification for W6 and M5 be reduced to be in line with the Regional qualification, reducing from level 6 to level 5; motion was made, seconded and approved.

No further business coming before the meeting, Stan Switzer made a motion to adjourn seconded by Brian Guyer. The meeting was adjourned at 10:50 a.m. The tournament selection for the 2017 year then followed.
